

VILLAGE ORDINANCE

NO. 115

AN ORDINANCE TO ADOPT BY REFERENCE THE UNIFORM TRAFFIC CODE FOR MICHIGAN CITIES, TOWNSHIPTS AND VILLAGES.

THE VILLAGE OF EDWARDSBURG ORDAINS:

Section 1. CODE ADOPTED

The Uniform Traffic Code for cities, townships and villages promulgated by the Commissioner of State Police and filed with the office of the Secretary of State on July 20, 1976, effective August 4, 1976, and the amendments thereto, filed with the office of the Secretary of State on July 27, 1979, effective August 1, 1979, are hereby adopted by reference as in this ordinance modified.

Section 2. REFERENCES IN CODE

References in the Uniform Traffic Code for Michigan Cities, Townships and Villages to "governmental unit" shall mean the Village of Edwardsburg.

Section 3. NOTICE TO BE PUBLISHED

The Village Clerk shall publish this ordinance in the manner required by law and shall at the same time publish a supplementary notice setting forth the purpose of the said Uniform Traffic Code and of the fact that complete copies of the Code and the amendments thereto are available at the office of the Clerk for inspection by and distribution to the public at all times.

Section 4. CONFLICTING ORDINANCES REPEALED

Ordinance Amendment to the Uniform Traffic Code passed at the meeting of July 16, 1979, relating to traffic are hereby specifically repealed. All other ordinances inconsistent with the provisions of the Uniform Traffic Code are, to the extent of such inconsistency, hereby repealed.

Section 5. WHEN EFFECTIVE

The Uniform Traffic Code will be in effect in this governmental unit ten days after the passage of this adopting ordinance.

NOTICE OF ADOPTION OF UNIFORM TRAFFIC CODE

Notice is hereby given that pursuant to the provisions of Act 62 of the Public Acts of 1956, State of Michigan, the Uniform Traffic Code for cities, townships and villages as amended was adopted by reference by the Trustees of the Village Council of Edwardsburg on the 18th day of February, 1980.

The purpose of such Code is to regulate the operation of vehicles, to provide for the regulation and use of streets, highways and alleys and other public and semi-public places within the Village of Edwardsburg and to provide penalties for the violation of said Code, pursuant to Act 510, Public Acts of 1978.

Complete copies of the Uniform Traffic Code and the amendments thereto are available at the office of the Village Clerk for inspection by and distribution to the public at all times.

No further or additional publication of the Uniform Traffic Code is required or contemplated.
